### **Membership Application**

In order to become a Racing Association of Miami member you must first fill out the application. All new members are on probation during the first 6 months of membership. New and existing members and are expected to participate with various tasks during club work days, special events, club racing and district racing.

Proof of the current NAMBA membership is required every year for the Racing Association of Miami membership renewal. Memberships expire December 31<sup>st</sup> and are renewable during the month of January of the following year. All membership fees/donations are non-refundable. All club rules are to be followed at all times when practicing, club racing and district racing at our race site. New members and existing members are required to read and understand rules contained in this document before joining the club.

All members of the Racing Association of Miami are Safety Officers, and have an obligation to ensure that all members and their guests operate their boat in a safe manner consistent with the NAMBA Rules, and Racing Association of Miami Safety Code. All Racing Association of Miami members are duly authorized agents for the purposes of ensuring that safe boating conditions exist at all times and are empowered to request any unauthorized personnel to leave the club lake site.

Please remember, club rules prohibit non-members from using the Racing Association of Miami Lake site unless accompanied by an active member (limit 2 times) or by appointment with a club officer.

### **Lake Site Rules**

1. The Racing Association of Miami Safety Code will be in effect at all times.
2. No radios will be turned on without checking first that the frequency is not in use.
3. All radios in use will have a frequency pin.
4. Any person not complying with radio use and frequency pins rules will have their club privileges immediately suspended.
5. All engines are to be equipped with factory or other expansion type mufflers. Engines starts in the pit area will be made with the boat facing the water. During club and district racing only boats "on the clock" are allowed to start their engines.
6. No smoking is permitted in the pit area.
7. A responsible adult must accompany all minor at all times. For safety reasons, all minors are prohibited from entering the pit areas not racing that heat.
8. No minors are allowed to be in the retrieved boat.
9. No open flames permitted in the pit area.
10. Due to safety sanitary conditions, dogs are not permitted in the pit area.
11. Members and guests are responsible for keeping their pit area clean and free of trash when leaving. If you brought it with you, then you must take it with you please.
12. Club members must be ready to produce on demand to officers of the park the NAMBA and Club I.D. cards, when using the Lake on non-race days or you could be asked to leave the Lake due to safety reasons.
13. No open toes will be allowed in pit area.
14. Please we are trying to foster a family atmosphere keep language in control and your attitude.
